The school Bursar was present at the meeting and asked to include a verbal update on the finance position to accompany the monthly monitoring that was circulated to governors with the meeting papers.

The Headteacher has received a parental request and requested it to be considered by the governors for decision.

6. Approval of Minutes from 25th May 2022 and 7th June 2022:

8. Governor training and development:

Having declared an interest in the following agenda item, Charlotte Robson withdrew from the meeting

Charlotte re-joined the meeting following her successful co-option.

The Governing body, having held a parent governor election in accordance with procedures outlined in NYCC policy documents and the Standing Orders of BSNS, confirmed Kathryn Sandercock as a new parent governor. Kathryn is duly appointed for a four-year term.

Kathryn and Charlotte will meet with Headteacher and Chair for an induction and welcome to Nursery in due course.

Having declared an interest in the remaining agenda items by virtue of being a staff member, Daisy Cairns left the meeting at 6.25pm

9. School development and Improvement plan:

This agenda item has been recorded in the confidential minutes.

10. Any Other Business previously identified:

The Bursar gave a verbal report to accompany the monitoring statement provided prior to the meeting. The monitoring is tracking as expected, some variances in income and expenditure have evened out the overall position.

The central finance team are now advising that energy costs are going to exceed the start budget estimates. The nursery was asked to plan for an electricity increase of 55% and a gas increase of 65% for the current year. It is now expected that costs will soar to an increase of 110% for electricity and between 159%-350% for gas. With this increase factored in, the governors will need to consider cost efficiencies for the current year.

The Government has announced a consultation on nursery funding, which BSNS will respond to in early September.

The funding rate for 2 year old places is increasing to include a premises factor.

The supplementary funding for maintained settings is increasing from £2.56 per hour to £3.80.
